GAROFALO HEALTH CARE S.P.A.: TREASURY SHARE BUY-BACK ANNOUNCEMENT

Rome, April 29, 2019 – Garofalo Health Care S.p.A. (the "**Company**" or "**GHC**"), listed on the MTA segment of the Italian Stock Exchange and an accredited private healthcare leader (LEI code 815600C851C90CAE6438), with regards to the treasury share buy-back programme in service of the share incentive plans approved by the Company approved by the Shareholders' Meeting of September 26, 2018, whose launch was approved by the Board of Directors on January 29, 2019, as announced to the market on the same date as per Article 144-*bis* of Consob Regulation No. 11971/1999, announces that between April 23 and April 26, 2019, it acquired on the MTA segment of the Italian Stock Exchange 11,000 GHC shares (ISIN code: IT0005345233), equal to 0.01% of the share capital, at an average price of Euro 4.0624 per share, for a total of Euro 44,686.62.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.
