### GAROFALO HEALTH CARE S.P.A.: TREASURY SHARE BUY-BACK ANNOUNCEMENT

**Rome, October 2, 2023** - Garofalo Health Care S.p.A. ("**GHC**"), listed on the Euronext STAR segment of the Italian Stock Exchange (LEI code 815600C851C90CAE6438), with regards to the treasury share buy-back programme authorized by the Shareholders' Meeting of April 28, 2023, as announced to the market on the same date as per Article 144-bis of Consob Regulation No. 11971/1999, announces that between September 25, 2023 and September 29, 2023, it acquired on the Euronext Milan segment of the Italian Stock Exchange 36,317 GHC shares (ISIN code: IT0005345233), equal to 0.04% of the share capital, at an average price of Euro 4.4675 per share, for a total of Euro 162,245.84.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.
